For payment orders/transactions for amounts exceeding €10.000 (or the equivalent in another currency), the exchange rate used is as set in each case by the Treasury Department of the Bank (special rate).
- 2. Exchange rate used for the value of payment orders/transactions, also applies for any commissions and charges applied for such payments.
- 3. "Outward payments" are the payments executed to other Banks and "payments within the Bank" are the payments executed to accounts held with Eurobank Cyprus Ltd.
- 4. Payment instructions received via telephone are acceptable only in cases of payments within the Bank a) between accounts of the same account owner and b) from personal sole accounts to personal joint accounts and vice versa or from personal joint accounts to personal joint accounts provided that the beneficiary or any one of the beneficiaries is the same and is authorized to sign the said payment instruction.
